Robert L. Bailey, Commissioner, stated he wanted the record to show he opposed the resignation because he believed this to be a political firing. Commissioner Bailey further stated that Mr. Zoeller was a good family man and a good County Manager and the other two Commissioners had not given him a good reason except they did not like the way he manages. Commissioner Bailey went on to say that Chris Tatum would become interim County Manager and he does not have anything against Mr. Tatum, however, he believed Mr. Tatum was not qualified to prepare the county budget.

Commissioner Bailey stated that when former County Manager, Glenn White, was fired, he was given three months to find a job and he believed Mr. Zoeller should have been given the same courtesy.

Nancy Cartmill, President, **moved to appoint Chris Tatum as interim County Manager until the position could be advertised.** Anne Yon, Commissioner, seconded the motion and the vote was as follows:
