Karen S. Cole, County Clerk, addressed her 402 County Clerk budget stating she was requesting a 7.5 percent overall salary increase for her employees, explaining that she preferred to give merit based raises as opposed to across the board increases. Ms. Cole stated that she was requesting \$1000 be added into the telephone line item. Additional funds were also needed for equipment repair and maintenance.

Ms. Cole also informed the Commission that a space consultant was currently looking over her offices to figure out what to do about the space issues that were being encountered. Ms. Cole told

<u>ADELL CHANDLER – CIRCUIT CLERK</u>

Adell Chandler, Circuit Clerk, explained to the Commission that her office was very busy and it was impossible for them to complete their tasks during normal business hours. Mrs. Chandler stated that there was no money in the overtime line item, and that they were currently unable to offer the employees paid time off to compensate for the overtime hours worked. Mrs. Chandler also requested \$5,000 for office supplies, due to paper prices rising, and that each clerk now had a printer at their desk and the cost of replacement ink cartridges was substantial. Mrs. Chandler also requested \$11,000 for the transition of a part-time filing clerk to a full-time filing clerk.

OTTIE ADKINS - ASSESSOR

Ottie Adkins, Assessor, reported that his budget would show a decrease of approximately \$5,000 from the previous year's budget. Mr. Adkins stated that he did not formally request a salary increase for his employees but would like for them to receive whatever the rest of the courthouse employees were awarded
